.1 LOCAL TESTING INFORMATION

- The City of Boston provides an online list of COVID-19 testing sites, both walk-in and by appointment only. <https://www.boston.gov/departments/public-health-commission/covid-19-testing-sites>
- BPHC continues coordination to expand access to COVID-19 testing sites in communities across the city. New testing sites launched this week include:
 - Jubilee Christian Church, Tuesdays through Thursdays 12:00 PM – 7:00 PM; walk-ins are welcome.
 - Lilla G Frederick Pilot Middle School, Fridays 5:00 PM – 9:00 PM, Saturdays 12:00 PM – 8:00 PM, and Sundays 10:00 AM – 6:00 PM; walk-ins welcome, testing occurs in the gymnasium located at the rear of the building.
- BPHC launched a free, high-capacity testing site at the Bruce C. Bolling Building in Roxbury, with a capacity of 1,000 tests per day, open Tuesday through Saturday, from 12:00 PM – 8:00 PM. Self-administered PCR tests are available on site and results will usually be available within 24 hours of testing.

Boston Public Health Commission updates COVID information regularly. Testing and vaccine sites include the Bolling Building in Roxbury, the Anna M. Cole Center in Jamaica Plain, and the West End House in Allston. For more information, call 333 or [CLICK HERE](#).

We have three scholarships that are designed to serve the our interns, residents and the Boston community.

The three Scholarships being offered are as follows:

[The Ralph D. Smith Community Service Scholarship \(Up to \\$3,500\)](#), is defined as a scholarship for those “who have demonstrated community service in the Madison Park Village and Lower Roxbury areas.” -Defined as residents who live in the 02119, 02120 and 02121 zip codes. This scholarship is also renewable.

[The Haynes Family Scholarship \(Up to \\$3,500\)](#), for Boston residents affiliated with MPDC through a program or other involvement. This scholarship is also renewable.

[The Danette Jones Scholarship Fund \(Up to \\$1,000\)](#) is for high school seniors who are affiliated with MPDC or are Roxbury residents who have demonstrated a commitment to community service.

Altogether, we award up to **\$50,000 every year** to help our applicants offset the costs of post-secondary education.

Depending on qualifications, applicants can apply to a college, university, trade, certification, or licensed program.
