Invitation to Join Bimonthly BHA Meetings

I am writing to formally extend an invite to join a Community Leaders meeting with the City and engagement team every other month. These meetings will focus on complex topics that are coming up throughout the engagement process; they will be a venue to work through nuanced design, public investment, and planning discussions. All meeting attendees will be compensated for their time at a rate equivalent to the engagement consultant team (\$125 per hour-long meeting).

Perhaps it goes without saying, but: the engagement process so far has uplifted a wide range of priorities, goals, and questions. This is understandable when considering that we've been in discussion with business owners, elected officials, neighborhood associations, and residents (some of whom drive, some of whom use public transit, and some of whom rely on alternate modes of travel) – just to name a few. We hope to integrate the Community Leaders meeting as a space to follow up on everything we're hearing, particularly when we're hearing a number of *competing* priorities. For example, there are inherent tensions between the goal of pedestrian safety and increased car travel efficiency.





Notice of Funding Opportunity for FY2022 Tribal Heritage Grant Program

Applications are due March 29, 2023

The National Park Service's [Tribal Heritage Grants Program](#) (THG) is now accepting applications for competitive grants. National Park Service's Tribal Heritage Grants Program focuses on protecting oral histories, plant and animal species important in tradition, sacred and historic places, and enabling the establishment of tribal historic preservation offices. The THG Program is funded by the [Historic Preservation Fund](#) (HPF) and is administered by the NPS. Approximately \$500,000 is available

for the THG Program in FY2022.

Applications are due March 29, 2023.

Available Grant Funding

Grants are awarded through a competitive process and do not require non-Federal match. Federally-recognized Indian Tribes, Native Alaska Villages/Corporations (Tribal Governments), and Native Hawaiian Organizations (as defined by 54 U.S.C. § 300309, 54 U.S.C. 300313, and 54 U.S.C. 300314) are eligible to receive THGs for cultural and historic preservation projects. Process and Deadlines

Applications are due **March 29, 2023**. All applications must be made through Grants.gov. No paper applications will be accepted. Registration in Grants.gov, SAM.gov, and other federal systems can take up to four weeks, so please start early.

FY2023 Grant Applications Coming Soon

Underrepresented Community (URC) Grant Program

The Underrepresented Community (URC) grant program supports the survey, inventory, and designation of historic properties that are associated with communities currently underrepresented in the National Register of Historic Places. Congress has appropriated **\$1.25 million** for this grant program in Fiscal Year 2023. Applications are anticipated to open in Spring of 2023. Projects must result in the submission of a new nomination to the National Register of Historic Places, or an amendment to an existing nomination to include underrepresented communities.



History of Equal Rights (HER) Grant Program

The History of Equal Rights (HER) grant program supports the preservation of sites related to the struggle for any or all people to achieve equal rights in America. Congress has appropriated \$5 million for the program in Fiscal Year 2023.



Applications are anticipated to open in Spring of 2023. The History of Equal Rights grants are not limited to any specific group and are intended to include the broadest possible interpretation of equal rights for any American. The HER program funds site specific bricks-and-mortar preservation and pre-preservation projects.



The Notice of Funding Opportunities (NOFO) for our FY23 programs are anticipated spring through fall 2023. We recommend applicants set up a saved search on Grants.gov for CFDA 15.929 for Save America's Treasures and 15.932 for Historically Black Colleges & Universities and 15.904 for all other programs to be notified when the opportunity becomes available. Here are instructions on setting up a saved search on Grants.gov [Subscribe to Saved Searches \(grants.gov\)](#). The application period is typically 90 days. Therefore, the deadline to apply will be 90 days after the NOFO is posted to Grants.gov. Because the window to apply for funding is limited, we encourage applicants to plan well ahead of the deadline. New! Healthy Neighborhoods Initiative Funding Opportunity: Allston/Brighton, Mission Hill and Roxbury

Beth Israel Deaconess Medical Center (BIDMC) is excited to launch the third and final Request for Proposals (RFP) for *Healthy Neighborhoods Initiative* funding.

Through this RFP, three coalitions – in the Boston neighborhoods of Allston/Brighton, Mission Hill and Roxbury – will be selected to receive \$395,000 each to develop and implement a community-led project in their neighborhood.

Healthy Neighborhoods Initiative RFP: At-A-Glance

What: A unique funding opportunity centered on the principles of inclusion, community engagement, health and racial equity, and taking an evidence-informed or evidence-based approach.

Who: Community Collectives -- coalitions, committees, or groups of residents that demonstrate an ability to facilitate an inclusive, broadly represented, and community-driven and led process. [See the full RFP](#) for additional information about eligibility.

When: Proposals are due by 5 p.m. Eastern Daylight Time on **March 30, 2023**, and applicants will be notified by April 20, 2023. Project plans will be implemented over a period of up to two years. [See the full RFP](#) for other key dates.

Where: The Boston neighborhoods of Allston/Brighton, Mission Hill and Roxbury.

Why: To facilitate collaborative efforts that enhance neighborhood assets and resident capacity to address specific opportunities in their community, drawing on the strengths found in each neighborhood.

Grantee Spotlights

**Bridge Over Troubled Waters
(Housing Affordability, Jobs and
Financial Security and Behavioral
Health Grantee)**



With funding from BIDMC, [Bridge Over Troubled Waters \(Bridge\)](#) has expanded their street outreach program into historically underserved communities in Boston to reach young people 24 years old and under who are experiencing homelessness or housing instability to connect these youth with resources and support services at Bridge. Peter Ducharme, Bridge's Director of Clinical Services, shared a few updates.

One programmatic success: “By expanding our outreach to community-based organizations in Dorchester and Roxbury, we were able to connect with two new landlords in the community to work with. We have successfully reached 49 youth,

provided behavioral health therapy, job training and/or financial assistance to 29 of these youth and have assisted 7 young people in obtaining housing through our Rapid Re-Housing program.”

One thing learned during program implementation so far: “While Bridge has been doing street outreach for over 50 years, we have modified our approach by partnering more strategically with other local service providers. We found that many local agencies were working with young people who are experiencing housing instability but were struggling to connect them with resources. By expanding our partnerships we have been able to more quickly connect youth with housing and other supportive services.”

Fathers' UpLift (Behavioral Health Grantee)



[Fathers' UpLift](#), with funding from BIDMC, has expanded their mental health counseling, coaching, and advocacy to assist fathers with overcoming barriers that prevent them from remaining engaged in their children's lives. Christopher Haylett, Development Director at Fathers' UpLift, shared how their program has been helping men to overcome both internal and external obstacles to allow them to reach their full potential.

One programmatic success: “Over the course of 2022, the average Fathers' UpLift client saw decreases in every factor of distress and vulnerability that we measure except for one: anxiety about losing one’s job. For us, this is a significant win, as it’s a major priority of ours to simultaneously improve both clients’ mental health and also resolve root factors behind many mental health stressors.”

One thing learned during the implementation of the program so far: “Since beginning our partnership with BIDMC, we have expanded our evaluation capacity and learned to utilize evaluation as both a tool for measuring individual client progress and for shaping our programming as a whole. For example, through our enhanced data collection, we discovered that food access was a much more significant stressor for our client base than we had previously understood. With that knowledge, we partnered with local nonprofits and began providing food drop-offs and grocery gift cards.”

The Mayor's Office of Housing

In March, join the Mayor's Office of Housing for two public hearings seeking citizen input on the housing and community development priorities for the Program Year 2023 Action Plan. The new program year begins July 1, 2023.

The Action Plan is submitted annually to the United States Department of Housing and Urban Development (HUD), and serves as the City's application and plan for using an estimated \$28 million in HUD resources from these four programs:

- Community Development Block Grant (CDBG)
- HOME Investment Partnerships (HOME)
- Housing Opportunities for Persons with AIDS (HOPWA)
- Emergency Solutions Grant (ESG) programs.

The Mayor's Office of Housing will host both a virtual and an in-person hearing.
